He had an incredible impact on the composition of government in this part of the State.

WHERE WE STAND

The New York State Conservative Party is the only legally recognized Conservative Party in the nation. This is partly because New York allows cross party endorsements of candidates by all political parties. Unlike other political parties, the Conservative Party stands for precise positions on the relevant issues of the day. Most of our enrolled Conservatives and endorsed Candidates support many of our beliefs of: lower taxes, less government, Life, public safety, the 2nd amendment, a meritocracy, patriotism, hard work and individual initiative, electoral honesty, fiscal sanity, the selection of

federal judges who will interpret the Constitution rather than re-write it, and national sovereignty and security. At this critical and pivotal time in our nation's history, America, New York State, and Monroe County need and deserve the implementation of our common-sense Conservative philosophy.

ELECTION 2020 AND BEYOND!

Last year's elections produced mixed results for the Monroe County Conservative Party. We endorsed 116 conservatively orientated candidates, most of whom were victorious. We were the margin of victory in 5-7 County Legislature races. Then County Executive Cheryl Dinolfo received 14,662 votes on Row C.

This year we have endorsed 30 candidates for public office. We have a tradition of endorsing and helping to elect very good judges. An important and competitive race has developed for the Monroe County Surrogate Court. In June our candidate Elena F. Cariola won every contested primary, and now has seven lines on the ballot against one for her challenger. Elena has momentum, 9 years of experience as a Deputy Public Administrator (an Officer in the Surrogate Court) and all the personal and professional qualities that would make her an excellent Surrogate Court Judge. In the four State Supreme Court races, we are supporting Justice Dan Doyle and Appellate Division Justice Steve Lindley, both of whom are running for re-election, and County Court Judges Vince Dinolfo and Sam Valleriani.

This year Senators Joe Robach and **Rich Funke** are retiring. Joe is retiring after almost 30 years in the State Legislature. He has developed a tremendous reputation for constituent service, support for our region, and community engagement. Rich reclaimed the east side Senate seat for the Republicans in 2014, and immediately put his common sense conservative principles to work for the district and the region. We have endorsed Mike Barry for Joe's seat, and Chris Missick for Rich's seat.

Next year is a "Super Bowl" election year. All 29 Monroe County Legislature seats are up, in addition to a Supreme Court Seat, Town Supervisors, Town Boards, Town Judges and many other local candidates. In all we will be endorsing more than 120 candidates. The Monroe County Conservative Party intends to play a pivotal role in the future of Monroe County elections.

RANDOM THOUGHTS ON POLITICAL ISSUES IN ROCHESTER, ALBANY AND WASHINGTON

This year we were unable to hold our Annual Conservative Dinner for the first time in 58-years. We are hopeful (optimistic?) that we will be in a position to renew the tradition next year. / In 2016 Hillary Clinton stated that "you could put half of Trump supporters into what I call the single...basket of deplorables". This year Joe Biden accused President Trump of dividing the nation and bringing out the worst in people, but then noted that "there are probably anywhere from 10% to 15% of the people out there that are just not very good people..." At this rate maybe most of us will be tolerated by 2024. / Where are the protests for the 2 ambushed Los Angeles Deputies? / Media Bias: Conservatives have long believed that the so-called mainstream media has a sharp leftist bias. Perhaps one of the President's enduring gifts to the country has been to expose that bias more clearly for all to see. In a recent poll fully 60% of respondents stated that they thought press coverage of Trump was unfair. The media is totally compromised. / By now, it is apparent that President Trump was a victim of a knowingly unjust attempt to subvert his 2016 victory. / House Speaker Nancy Pelosi was caught on video entering a hair salon without her mask on September 3. This despite her sharp criticism of the President, Republican Governors, and many citizens who apparently aren't taking the pandemic seriously enough. I guess there is a different set of rules if you are in the political and moral elite. / Voter Fraud Much has been written about the possibility of voter fraud in the upcoming elections. Democrats speak of voter suppression while Republicans ask for ballot security. So now disallowing improperly cast or illegal votes is "suppression"? It is self-evident that mail voting is more prone to fraud than in-person voting, which may explain why the concept of mail voting and early voting is so popular in some quarters. / How is it that you can be sanctioned or shut down for trying to run a business or a church service without observing Government restrictions (or at the very least scolded and criticized) while virtually no attempt was made to curtail the large protests in the summer, whether peaceful or violent? / Democratic Dysfunction: The local Democratic Party is experiencing a period of dissention and turmoil. In June there were several contentious primaries, which were then followed by a fight over who would represent the Democrats as Election Commissioner and a struggle over who would be selected as the Democratic Minority Leader in the County Legislature. There is a new Democratic County Chair. / Assemblyman **David Gantt** passed away this year, at the age of 79. He served his constituents tenaciously for 10 years as a Monroe County Legislator, and then for 37 years as a New York State Assemblyman. R.I.P.
